This letter from Private (Pte) Harry William Manchester to his sister, Miss La Verne Woods (née Manchester) of Highland Park, Michigan, was written and posted from Windsor, Ontario, Canada, on September 10, 1939.

The content of the artifact describes social Harry William Manchester's activities.

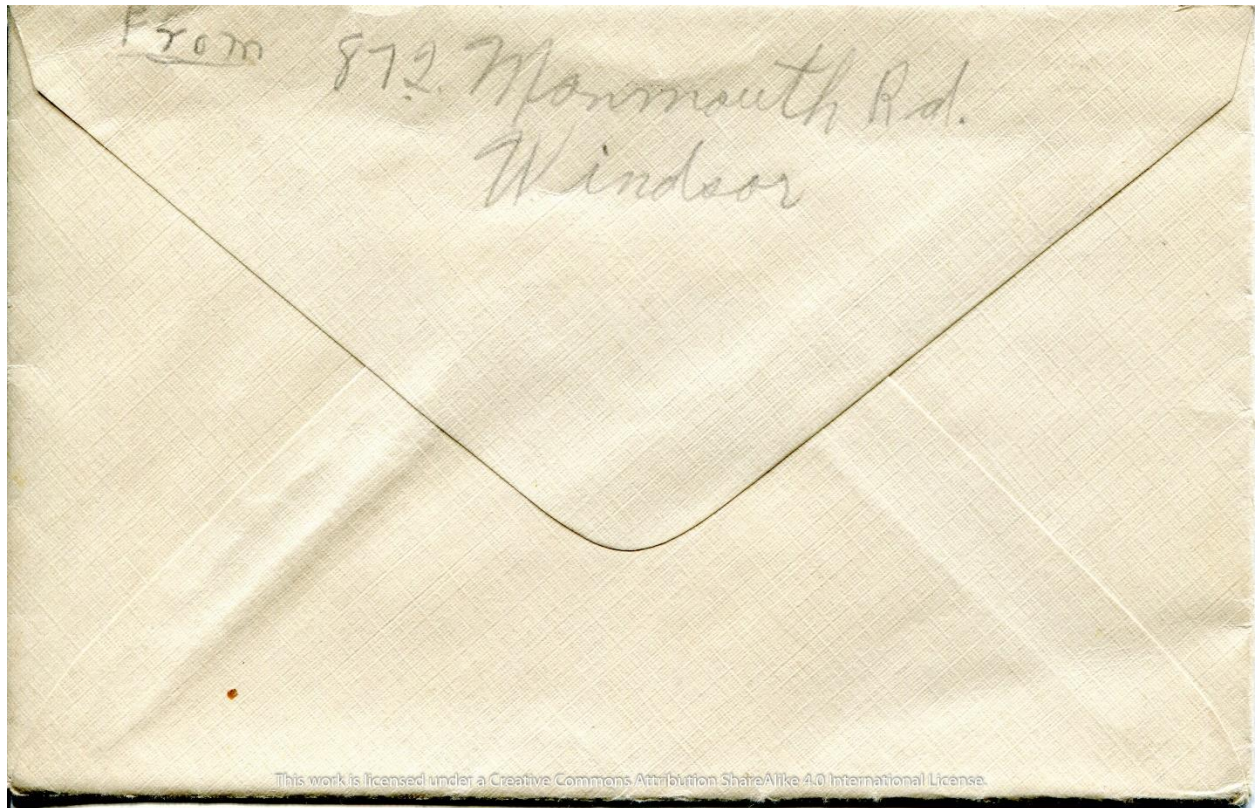
